For the AAUW portion of the meeting, our treasurer once again explained the necessity of raising our dues next year in order to continue to continue the scholarships and projects we do. She shared two possible budgets with us- one with the proposed increase and one without. We will have a vote on the budget, the proposed dues increase, and the slate of officers to elect at the April meeting. Thanks, Sherri Bentley

TREASURER REPORT

Attached are two proposed budgets for the 2023 - 2024 year for our branch. There is one WITH-OUT A DUES INCREASE and the other is WITH A DUES INCREASE. Which one we vote on will be based on the outcome of the proposed increase in our branch dues to \$125.00. The only difference between the budgets is the amount of money we receive from MEMBER DUES and the amount of money spent in COS Scholarships.

If we do NOT increase our dues and leave the amount at \$100.00 OUR branch will receive \$8.00 of that money.

Regardless of the outcome of the dues increase we are obligated to the following:

AAUW National \$72.00

CA - AAUW \$20.00 Our Branch \$ 8.00*

*\$8.00 per branch member multiplied by our membership of 100 equals \$800 in membership dues income; which is not enough to sustain our organization. Our minimum (meager) operating expenses are approximately \$10,000. This amount is used to pay insurance (liability and directors and officers), meeting space for board and general meetings, monthly meeting program expense, annual roster printing, post office box annual rental and booksale expenses. This does NOT include the programs we are KNOWN for: Expanding your Horizons, COS Scholarships or Tech Trek, which adds approximately \$18,000 more to our expenses. We do have money in our Morgan Stanley Account of approximately \$64,000. Based on our standing rules we are able to (and do) utilize the interest and dividends from the initial investment of \$58,000 (which we received from the sale of the Clubhouse in 1973). The initial investment is to remain intact, per our Standing Rules.

If the dues increase were to pass our obligation to AAUW National and CA-AAUW would remain the same, at \$72 and \$20 repectively, however OUR Branch would receive \$33.00. BIG DIFFER-ENCE. It would not cover all of our operating expenses but it would amount to \$3,300.00 a \$2,500 difference!

I would like to thank the members of the Finance Committee - Susan Franciskovich, Sherri Bentley, Susan Cunningham, Maile Melkonian, Lisa Silva and Linda Tucker for their help and input into creating these budgets.

AAUW CALIFORNIA LOBBY DAYS

AAUW California Lobby Days this year were on March 21 and 22.

This is an opportunity for AAUW members to meet with their state representatives and/or their staff to inform them about AAUW and advocate for their support of current AAUW CA priority bills.

Participants:

Four members of our Branch participated this year: Maile Melkonian, Lisa Silva, Nancy Adalian, and Terry Cornelius. They met with **Senator Shannon Grove's** Legislative Aide Taylor Bartucca and **Assembly Member Vince Fong's** Legislative Director Spencer Street.

What follows is a brief summary of each bill and a recap of the meeting our branch held with the legislative staff.

AAUW California Top Three Priority Bills

Assembly Bill 1394

Author: Assembly Member Buffy Wicks

Social Media Platform Liability For Child Sexual Abuse and Trafficking

The Problem

Social media platforms are aware that sexual abuse, exploitation and trafficking of children are originating on their platforms; yet they continue to rely on inadequate self-policing of platform users.

The Proposed Solution:

This bill would provide an incentive for social media platforms to better police their designs to reduce the ease with which predators can use them to attract potential teen victims by allowing victims of child sex exploitation to sue large social media platforms:

If they can prove the platform knowingly, recklessly or negligently facilitated, aided or abetted child exploitation,

And/or if the platform refuses their request to render invisible any images or videos posted of them on the platform.

Senate Bill 287

Author: Senator Nancy Skinner

California Social Media Platform Liability For Child Addiction and Harms The Problem:

Our youth are currently experiencing an unprecedented mental health crisis, and researchers attribute a significant part of the cause to their social media use. This includes access to dangers such as Fentanyl.

The Proposed Solution:

Would prohibit social media platforms from knowingly or negligently using a design, algorithm, or features that causes child users to receive content that facilitates exposure to dangerous additions or harm to themselves or others. Provides a penalty of up to \$250,000 for each violation.

Assembly Bill 549

Coauthors: Assemblymembers Rebecca Bauer-Kahan, and Lisa Calderon The California Elimination of Discrimination Against Women Act The Problem:

Women, including women in California, continue to face discrimination in the areas of health care, employment, economic development, educational opportunities, and gender-based violence.

The Proposed Solution:

This bill was proposed by the Convention on the Elimination of All Forms of Discrimination Against Women (CEDAW), which is an international "Bill of Rights" for women. The bill seeks to eliminate the discriminatory acts identified by CEDAW by requiring state agencies to evaluate their departments and report to CEDAW annually.

VISALIA-SEQUOIA BRANCH / STATE REPRESENTATIVES MEETING HIGHLIGHTS:

Before discussing the bills, we provided some information on AAUWV's mission and the work this branch has done here locally over years. Neither office was familiar with these three bills, as they are still in committee. But each office had reasons to be interested in them. Spencer Street (Fong's office) is tasked to address the Fentanyl problem. So he is especially interested in social media's role in that. Taylor Bartucca (Grove's office) was very engaging in terms of learning about AAUW and discussing the bills. She said that Senator Grove is authoring three bills related to trafficking. So she is especially interested in addressing social media's role in that.

Neither office committed one way or the other in terms of voting for the bills, but both asked for even more information. We are currently working with AAUW's State Public Policy group on the most effective way to facilitate that.

This annual event gives us the opportunity to engage with our local legislators or their staff. They learn about the bills we are co-sponsoring or supporting. But they also learn about — some for the first time — our organization and its important mission:

"AAUW has been empowering women as individuals and as a community since 1881. For more than 130 years, we have worked together as a national grassroots organization to improve the lives of millions of women and their families."

Recognizing the gender gap in policy-making positions at all levels of government, AAUW California launched this new program to train and inspire junior and senior high school girls.




The girls formed campaign teams, and wrote stump speeches, designed political ads, analyzed district demographics, and organizing campaign strategies. Each team created a 6-minute video for competition at the fifth and final session on March 25. Judges were professionals in this field, and first prize is internships for all team members!

GovTrek was completely on-line, and free to both students and Branches. I thoroughly enjoyed my experience as a volunteer facilitator.

All but one of the five sessions featured speakers—an impressive array of women in government at all levels, both elected and staff. The keynote for the last session was Senator Toni Atkins, President Pro Tempore of the California Senate. "Young people...are our *present and* future leaders," she emphasized, and advised, "Be your authentic self. ... and seek out


A lot of thought went into the "Team Abby" social media ad—one element of the final campaign simulation presentation.



mentors. I still rely on my mentors."

"Working with the girls over the past sessions makes me so optimistic about the future of our country," stated program director Shauna Oenning Ruyle.

President Sandy Gabe announced that AAUW-CA will add GovTrek to its raft of programs, and invited more participation in 2024.
